(NBPT) in solvent blend

N-STABLE 25 is a liquid concentrated fertilizer additive for use on urea and in UAN solutions. N-STABLE 25 contains 25% N-(n-butyl) thiophosphoric triamide, an urease inhibitor which inhibits the enzymatic activity of urease. By inhibiting urease enzyme activity, conversion from urea to ammonia is delayed and ammonia losses from volatility are minimized. N-STABLE 25 may be applied to all commercially grown crops and improved grass pastures. N-STABLE 25 may be used when applying urea or UAN solution for all forms of surface applications, including: Pre-Plant, Pre-Emergence, Side-Dress, Top-Dress, or other Post-Plant application.

SUGGESTED USE RATES

Urea 46-0-0:	3.1 liters/tonne (3 quarts/ton)
UAN Solutions (28-32%):	1.6 liters/tonne (1.5 quarts/ton)

DIRECTIONS FOR USE

Urea Blending:

Use a fertilizer blender with impregnation equipment or its equivalent to uniformly coat the urea particles. Blend **N-STABLE 25** with urea, before the addition of other fertilizer components or additives. If blend appears wet, a drying agent may be added to the fertilizer mixture. Add drying agent at approximately 1 kilogram per liter (2 pounds per quart) of **N-STABLE 25** and adjust up or down as desired pending outcome.

UAN Solutions:

Fill spray tank halfway with UAN and add **N-STABLE 25** directly to the UAN solution and agitate. Allow agitation to continue while adding remainder of UAN until thoroughly mixed into a complete solution.

NOTES

N-STABLE 25 is believed to be compatible with UAN and pesticides. Not all possible combinations have been tested, and therefore a jar test is recommended before use. When tank-mixed with pesticide solutions, the solution should be applied soon after mixing to avoid a possible reduction of the effectiveness of the active ingredient. Do not apply if rainfall exceeding 2 cm (¾ inch) is forecast. If rainfall exceeding 2 cm (¾ inch) is expected immediately after application, the granular urea or UAN solution will be carried below the surface and nitrogen loss from volatility may be diminished.
